- 協會中文名稱:** 澳大利亞華人攝影家協會
- 英文名稱:** Overseas Chinese Photographers (Australia) Association Inc.

- 宗旨:** 本會在澳大利亞新南威爾士州註冊為一非牟利,非宗教及非政治團體,以推廣攝影藝術為宗旨,鼓勵會員深入研究攝影技術和知識,促進和提高會員對攝影的興趣,舉辦各類型的攝影活動,在和諧友好的氣氛下互相學習,切磋分享.並與各地攝影團體聯繫,交流心得.
- 活動:** 月會,舉辦各項活動: 攝影講座、比賽、展覽、影及攝影旅遊團等.
- 會員:** 凡贊同本會宗旨,及願遵守本會會章的人士,均可申請加入.
- 權利:** 參加本會舉辦之一切活動,18歲及以上會員有投票權,選舉權和被選舉權.
- 義務:** 遵守會章,參與推動會務發展,按時繳交會費。如欠會費三個月以上,當自動退會。如再申請入會,須再繳交入會申請費和會費.
- 會員會費:** 普通會員 (每個財政年): 澳元\$30.00  
永久會員: 澳元\$300.00
- 會員大會:** 每年舉行一次,開會前十四日以電郵通知各會員召開。會員大會必須有五位或以上會員出席才可舉行。所有決議須通過絕對多數贊成票,才能生效。特別會員大會則在執行委員會認為必要時,或在不少於二十分之一全體會員聯署提出書面申請時召開。召開方法與會員大會相同.
- 委員會:** 由會員大會選出委員七人,然後互選出任正、副會長、秘書、財政及執行委員,組成執行委員會。處理日常會務、行政管理及財務運作,任期為一年.
- 解散:** 解散本會之議案,須在為此目的召開之特別會員大會中方可表決,同時必須通過絕對多數贊成票,方為有效。及在同一會議上,須同時議決資產的處理方案,所有淨餘資產,將捐贈慈善機構.

**Purpose:** The Association is a non-profit, non-religious and non-political organization registered in the State of New South Wales, Australia. It promotes the development of photographic art and encourages its members to study photographic techniques and knowledge and to promote and enhance their interest in photography. We hold various types of photographic activities, in a harmonious and friendly atmosphere to learn from each other, puzzle consultation to share and contact with local photographic groups, exchange of experiences.

**Activities:** The monthly meeting, held various activities: photography lectures, competitions, exhibitions, film and photography tours. Membership: Members who endorse the purpose of this Council and who wish to abide by the Constitutional Council may apply to join.

**Right:** to participate in all activities organized by the 18-year-old and above members have the right to vote, the right to vote and be elected.

**Obligations:** Comply with the Constitution, participate in the promotion of business development, and pay dues on time. Such as arrears of more than three months, when the automatic withdrawal. If you apply for membership, you will be required to pay the application fee and membership fee

**Membership Fee:** Regular Membership (annual fee/ financial year): AUD \$ 30.00  
Permanent Members: AUD \$ 300.00

**General Assembly:** held once a year, before the meeting 14th by e-mail to inform the members convened. The General Assembly must be attended by five or more members. All resolutions are subject to an absolute majority of votes in order to enter into force. The Extraordinary General Meeting shall be convened at such time as the Executive Committee deems necessary, or when not less than one-twentieth of the total number of Members have co-sponsored a written application. Held the same way as the General Assembly.

**Committee:** The members of the General Assembly elected seven members, and then elected each of the positive, vice president, secretary, finance and executive members, the composition of the Executive Committee. To handle daily business, administrative and financial operations for a term of one year.

**Disbandment:** The dissolution of this Council's motion shall be subject to the vote of the Special General Meeting convened for this purpose and shall be valid only by an absolute majority. And at the same meeting, the disposition of the assets should be resolved at the same time and all net assets will be donated to charitable organizations.
